

## SPAY/NEUTER CONTRACT

\*The Purchaser has been told verbally as well as in writing, previous to the sale of this dog:

---

that this dog is being sold as a PET ONLY, and that it MUST be spayed/neutered by 7 months of age, at the Purchaser's expense.

\*It is the responsibility of the ORIGINAL PURCHASER to ensure that the Seller receives verification that the spay/neuter surgery has been performed NO LATER THAN this dog's age of 7 months old, before the date of \_\_\_\_\_. Verification of this dog's spay/neuter surgery must be received by Seller no later than \_\_\_\_\_. Failure to comply with this agreement will be considered a breach of this contract, and the Purchaser understands that they, as the ORIGINAL PURCHASER, will then be liable for this dog's full breeding value, additional to the original sale price.

\*Purchaser is to send Seller a copy of their Vet's invoice bill for this dog's spay/neuter surgery, along with the performing Vet's name(printed), Vet's signature, phone number, and address, as well as the date the surgery was performed. Any proof of surgery must include a description of the dog (age, breed, color). For convenience, a pre addressed envelope, along with a proper form have been provided to Purchaser at time of sale. The form includes dogs description, and has spaces for owners name, surgery date, performing Vet's information, and performing Vet's signature. This information must be received by Seller no later than \_\_\_\_\_.

\*The Purchaser understands that this spay/neuter contract is an agreement that this dog is NEVER to produce a litter of puppies, either as purposely bred, or by accidental breeding. Should this dog be bred, even before the 7 month surgery cut off date, the Purchaser will be responsible for the full breeding value of this dog, additional to the original sale price.

\*This contract is still the Original Purchaser's responsibility to enforce in this dog's new home, should they for any reason sell/trade/give away/ transfer ownership of this dog.

\* If this dog is to die for any reason BEFORE its spay/neuter has been performed, a certificate of death from a veterinarian including: owner's name, date of death, description of dog (breed, color,age), Vet's name, phone number, address, and

signature, obtained at the Purchaser's expense (will not be reimbursed), must be received by Seller before the date of \_\_\_\_\_, or the Purchaser will be responsible for the full breeding value of this dog, additional to the original sale price.

\*Should Seller not receive the above listed, proper conformation of this dog's spaying or neutering by the date of \_\_\_\_\_, the Purchaser understands that they, as the Original Purchaser of this dog, will then be liable for this dog's full breeding value, additional to the original sale price. Purchaser will also be responsible for any legal fees incurred by the Seller in the event that this contract is breached.
